#### Item 3.02. Unregistered Sales of Equity Securities.

On September 30, 2008, Hecla Mining Company (<u>Hecla</u>) announced the calculation of the ratio at which it would issue shares of its common stock, par value \$0.25 per share, for a previously announced regular quarterly dividend on its outstanding 6.5% Mandatory Convertible Preferred Stock in the amount of \$1.625 per share. The total amount of such stock dividend is approximately \$3.27 million in Hecla common stock (or approximately 622,265 shares, with cash for fractional shares). The stock dividend payment date was on October 1, 2008. A copy of the press release making the announcement is filed herewith as Exhibit 99.1 and incorporated into this Item 3.02 by reference.

The issuance of shares to its existing holders of 6.5% Mandatory Convertible Preferred Stock is exempt from registration as it involves no sale for value in which any investment decision is made and/or no public offering pursuant to Section 4(2) of the Securities Act of 1933.

#### Item 8.01. Other Events.

As described above in Item 3.02, Hecla announced the calculation of the ratio at which it would issue shares of its common stock for a previously announced regular quarterly dividend on its outstanding 6.5% Mandatory Convertible Preferred Stock.
