 Appointment of Principal Officers.

On December 21, 2004, MetLife, Inc., a Delaware corporation (the "Company"), announced certain organizational changes, including the appointment of Catherine A. Rein, age 61, as the Chief Administrative Officer of the Company, effective January 1, 2005. Ms. Rein has been Senior Executive Vice President of the Company since September 1999 and President and Chief Executive Officer of Metropolitan Property and Casualty Insurance Company, a wholly-owned subsidiary of the Company, since March 1, 1999. Metropolitan Property and Casualty Insurance Company and its subsidiaries offer personal lines property and casualty insurance directly to employees through their employers, as well as through a variety of retail distribution channels. She has been Senior Executive Vice President of Metropolitan Life Insurance Company, an insurance and financial services company and wholly-owned subsidiary of the Company, since February 1998.

No final determination has been made regarding whether the change in Ms. Rein's responsibilities will cause the Company to amend her Amended and Restated Employment Continuation Agreement, previously filed as exhibit 10.17 to the Company's Annual Report on Form 10-K for the year ended December 31, 2001.

A copy of the press release issued by the Company on December 28, 2004 announcing certain organizational changes, including Ms. Rein's appointment, is attached hereto as Exhibit 99.1 and is incorporated herein by reference.
